 - d. Nicks, scratches, scarring or other marks on the body, whether they are permanent or semi-permanent in nature that may be the result of the body piercing procedure _____
 - e. Bleeding, drooling, spitting, vomiting, gagging, sneezing, loss of bladder control, loss of consciousness, loss of balance, tripping, falling and the consequences of the above-mentioned actions, whether they are intentional or unintentional. _____
 - f. Oral body piercings including but not limited to the lip, tongue, tongue web, cheek, etc. will cause swelling at the body piercing area and can cause mild or severe dental problems such as teeth chipping or breaking, gum disease, gum recession and other dental problems _____
- 3) I understand that Z-Edge Piercing Inc. will make every effort to successfully perform the body piercing on the minor child. However, if the child is resistant to receiving the body piercing, Z-Edge will try to perform the piercing for no more than 5 minutes. After which time Z-Edge will cease to try to perform the body piercing. I understand that once the procedure supplies are opened, I will be charged the full body piercing procedure price whether the minor receives the body piercing or does not. _____
- 4) I understand that body piercing is not an exact science. There are many unknown variables and not every body piercing comes out perfect. _____
- 5) I understand that performing body piercing on an infant is a hard & stressful procedure on the piercer, the minor and the parent. I understand that I may need to hold my minor child down for them to receive a body piercing. I understand that the minor child may kick, scream, cry, flail their extremities, bite, spit, vomit, jump, move, hit, etc. _____
- 6) I acknowledge that I have read this form in its entirety and I agree to hold Z-Edge Piercing inc. and the body piercer completely harmless of any unforeseen consequence resulting from the body piercing procedure. _____
